Mathematics of Selling



Formula for Markdown

$$\text{Reduced price} = \text{Original price} - \text{Markdown}$$

Diagram of a Markdown

Break-even point = Cost + Operating expenses

Operating loss = Break-even point – Reduced selling price

Absolute loss = Cost – Reduced selling price
